

ORDINANCE NO. 720

**COMBINED ANNUAL BUDGET AND APPROPRIATION
ORDINANCE FOR THE URBANA & CHAMPAIGN SANITARY DISTRICT,
FISCAL YEAR OF MAY 1, 2020 TO APRIL 30, 2021, BOTH INCLUSIVE**

BE IT ORDAINED by the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois:


SECTION 4. The following cash flow determinations have been made and are hereby made a part of the aforesaid budget.

- C. An estimate of the expenditures contemplated for the fiscal year is \$20,053,742.
- D. An estimate of the cash expected to be on hand at the end of the fiscal year is \$2,484,893.
