

## ORDINANCE NO. 731

### AN AMENDED COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR THE URBANA & CHAMPAIGN SANITARY DISTRICT, FISCAL YEAR OF MAY 1, 2022 TO APRIL 30, 2023, BOTH INCLUSIVE

Whereas, the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois adopted on April 26, 2022 a Budget and Appropriation Ordinance for the fiscal year of May 1, 2022 to April 30, 2023 (Ordinance No. 729); and

Whereas, the Trustees find it necessary to amend said Annual Budget and Appropriation Ordinance to provide for treatment plant facilities capital outlay and increased electricity expenses; and

Whereas, the procedures and notices required by Illinois law, including, but not limited to, the Illinois Municipal Budget Law (50 ILCS 330), have been complied with for amendment to the budget and appropriation,

**BE IT ORDAINED** by the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois that Sections 1, 2, 3, 4, and 5 of Ordinance 729 of the Urbana & Champaign Sanitary District are amended in the following respects:

A. Ordinance No. 729 (the Budget and Appropriation Ordinance for the Urbana & Champaign Sanitary District for the fiscal year May 1, 2022 to April 30, 2023) be amended in the following respects:

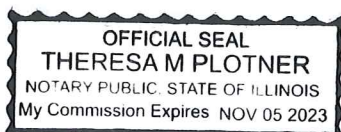
