

## ORDINANCE NO. 744

### AN ORDINANCE ESTABLISHING REVISED RATES FOR CONNECTION FEES AND INTERCEPTOR COST RECOVERY FEES OF THE URBANA & CHAMPAIGN SANITARY DISTRICT OF CHAMPAIGN COUNTY, ILLINOIS

**WHEREAS**, the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois adopted Ordinance No. 691 which, among other things, established rates for Connection Fees and Interceptor Costs Recovery Fees; and

**WHEREAS**, the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois has adopted Ordinances No.'s 698, 734 and 737 which, among other things, established revised rates for Connection Fees and Interceptor Costs Recovery Fees; and

**WHEREAS**, the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois has determined that it is necessary to revise said Connection Fees and Interceptor Costs Recovery Fees;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Urbana & Champaign Sanitary District of Champaign County, Illinois as follows:

#### SECTION 1. REVISIONS.

##### A. 2.3 CONNECTION FEES.

*Beginning May 1, 2025*      *\$580.00 per PE*

##### B. 3.2 INTERCEPTOR COST RECOVERY FEES.

*Beginning May 1, 2025*      *\$454.00 per PE*

C. Except as previously amended by Ordinances No.'s 698, 734 and 737 and further amended by this Ordinance No. 743, Ordinance No. 691 remains in effect.

#### SECTION 2. ORDINANCE IN FORCE.

This Ordinance No. 744 shall be in full force and effect from and after its passage, adoption, approval, and publication in accordance with the law on May 1, 2025, whichever time or event occurs the later.
