

Urbana & Champaign Sanitary District**Total Compensation over \$75,000****Fiscal Year 2026**

The following report is being provided in compliance with Public Act 097-0609 which requires that, within 6 business days after an employer participating in the Illinois Municipal Retirement Fund approves a budget, that employer must post the total annual compensation package for each employee having a total compensation package that exceeds \$75,000 per year. The information may be posted on the employer's website or at the principal office of the employer. For purposes of the Act, total compensation package means payment by the employer to the employee for salary, health insurance, a housing allowance, a vehicle allowance, a clothing allowance, bonuses, loans, vacation days granted, and sick days granted. It does not include on-call payments, call-in earnings, or overtime as these are not budgeted per individual. The District does not provide allowances for housing or vehicles.
